#### 3. Action

#### 3.1 Adoption of the Town of Bay Bulls 2025 Municipal Operating Budget

RESOLUTION: 2024-209 Councillor Ethan Williams / Councillor Corey Ronayne

BE IT RESOLVED that the Town of Bay Bulls adopt the proposed Budget as presented for the year 2025 effective January 1, 2025.

**BE IT FURTHER RESOLVED** that the Town of Bay Bulls, as per Section 77 of the *Municipalities Act, 1999* accepts and adopts the 2025 Municipal Operating Budget with total Revenues of \$3,787,361.14 and total Expenditures of \$3,787,361.14.

Taxes will be imposed as per Section 101 and the due date for the same will be May 31, 2025.

A 12% early payment discount shall be granted to residential property tax accounts paid in full by March 31, 2025 in accordance with Section 108.

Simple interest will be applied as per Section 107.1 of the *Municipalities Act, 1999* at a rate of 2% per month or 24% per annum.

Residential Property Tax shall be imposed at 5.0 mils

Commercial Property Tax shall be imposed at 14.75 mils

Minimum Property Tax shall be \$400.00

Minimum Vacant Land Tax shall be \$200.00

Business Tax shall be imposed as per Sections 120,121,122,123, and 124

Minimum Business Tax shall be \$450.00 as per Section 125

Utility Tax shall be applied at 2.5% of gross revenue and in accordance with the applicable legislation.
